- Images must have alternative text
- Buttons must have discernible text
- Links must have discernible text
- `` and `` must only directly contain ``, `<script>` or `<template>` elements
- Form elements must have labels
- Certain ARIA roles must be contained by particular parents
- `<html>` element must have a `lang` attribute
- Interactive controls must not be nested

The above-mentioned issues are currently being evaluated and planned for resolution.

We designed our site taking into account compatibility of assistive technologies with major modern web browsers. For the best experience, and security, please keep your browser version up to date and take security measures such as installing anti-virus software.

Ongoing monitoring

We will continue to consider accessibility when developing new features, run periodic audits to assess our site against applicable accessibility standards and integrate feedback from users into ongoing improvements.
