#### **Known limitations**

Despite our best efforts to ensure accessibility of our site, there may be some limitations, including:

- Elements with the role attribute use invalid values
- Buttons do not have a recognzable text
- Elements with a required ARIA role do not contain the necessary child roles
- ARIA buttons, links, and menuitems do not have an accessible name
- Form elements do not have an associated label
- Interactive controls are nested, causing accessibility issues
- Text links do not have a recognizable text
